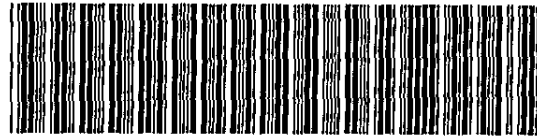

ARTICLE I

The name of the Riston Residential Contracting Inc.

ARTICLE II

Its initial registered office and principal office in the State of Florida s
445 Palmetto St, City of Dunedin FL, County of Pinellas .

The name of the initial registered agent at such address is Lina Garcia.

ARTICLE III

The nature of the business or purposes to be conducted or promoted is to engage
in any lawful act or activity for which corporations may be organized under the
Florida Business Corporation Act.

ARTICLE IV

The total number of shares of capital stock that the Corporation shall have
authority to issue is 1,000 all of which are to be common stock with a par
value of \$.01 per share.

ARTICLE V


