#### ARTICLE I NAME

The name of the Corporation is **PANORAMA TREE SERVICE**, **INC**. The address of the Corporation is 10401 Sedgebrook Drive, Riverview, Florida 33569-5799.

#### ARTICLE II DURATION

The Corporation shall have perpetual existence.

#### ARTICLE III PURPOSE
