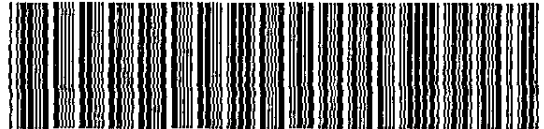

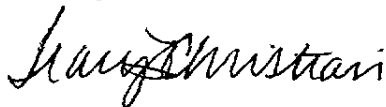

ARTICLES OF INCORPORATION

OF

MEDICINE EXPRESS, INC.

ARTICLE I

NAME

The name of this corporation is MEDICINE EXPRESS, INC.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State,

ARTICLE III

PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business as a pharmaceutical supplier of nursing homes, assisted living facilities, and surgi-centers.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".

ARTICLE V

PREEMPTIVE RIGHTS

Every shareholder, upon sale for cash of any new stock of this corporation, shall have the right to purchase his pro rata share thereof, as nearly

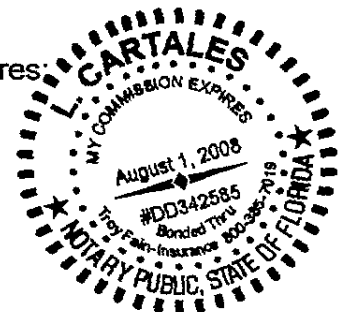
