I, Deborah Barker, the undersigned, who is licensed as a sales associate under Chapter 475 of the Florida Statutes, do hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida, these Articles of Incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida.

**ARTICLE I - NAME**

**ARTICLE II - PURPOSE**
