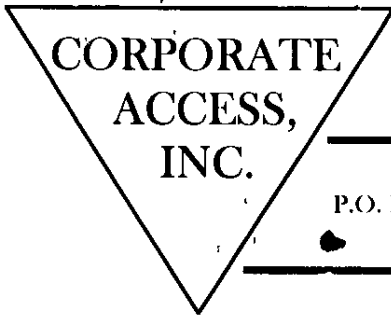

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendments to its Articles of Incorporation.


1. The name of the Corporation is French Wine Explorers, Inc.


