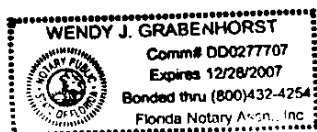
1. Thomas D. Plummer is the President of CRYSTAL BLUE WATER SERVICE, INC., a Florida corporation, (hereinafter "Corporation").
2. That the Corporation was administratively dissolved by the Florida Department of State on September 15, 2006.
