## ARTICLES OF INCORPORATION OF GULFSOUTH PRIVATE BANK

The undersigned, acting as directors for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt the following Articles of Incorporation.

#### ARTICLE I

The name of the corporation shall be GulfSouth Private Bank and its initial place of business shall be at 305 Main Street, Destin, Okaloosa County, Florida 32541.
