ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is JOSE ANTONIO ACOSTA, P.A., (hereinafter, "Corporation").

ARTICLE II - PRINCIPAL PLACE OF BUSINESS ADDRESS


ARTICLE X-SHAREHOLDERS MEETING REQUIRED
