**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF
ALLERGY & ASTHMA SPECIALISTS OF NORTH FLORIDA, P.A.**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation, pursuant to a consent meeting of all of the shareholders and the members of the Board of Directors held on the 1st day of September, 2007.

1. The first paragraph of Article IV is deleted in its entirety and the following is substituted in lieu thereof:

"The aggregate number of shares which this Corporation is authorized to issue is 5,000 shares of common stock. Of such shares, 2,500 shares shall be Class A Voting common and 2,500 shares shall be Class B Non-Voting common. Each share shall have a par value of \$1.00. The common stock Class A Voting and the common stock Class B Non-Voting shall be identical in all respects, except that the holders of the common stock Class B Non-Voting shall have no voting power for any purpose whatsoever and the holders of common stock Class A Voting shall, to the exclusion of the holders of common stock Class B Non-Voting, have full power for all purposes."

2. In all other respects except as specifically changed and modified in these Articles of Amendment to the Articles of Incorporation, all of the provisions contained in the Articles of Incorporation of Allergy & Asthma Specialists of North Florida, P.A. shall be and remain the same.
