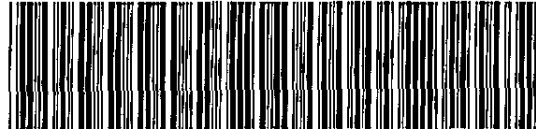

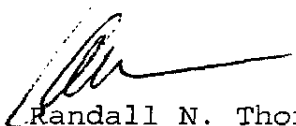

ARTICLES OF INCORPORATION
OF
JOE COX CONSTRUCTION, INC.

ARTICLE I. NAME

The name of this corporation is JOE COX CONSTRUCTION, INC.

ARTICLE II. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III. TERM OF EXISTENCE

The corporation shall have perpetual existence commencing on the date these articles of incorporation are filed with the Department of State of Florida.
