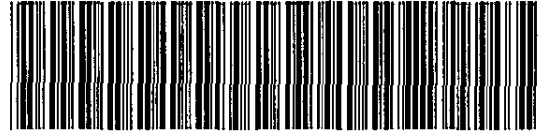

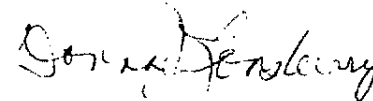

fullest extent permitted by applicable law.

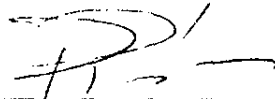

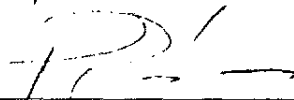
