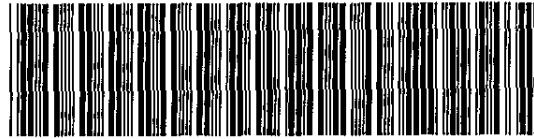


ARTICLE V REGISTERED AGENT
