ARTICLES OF INCORPORATION OF

DAWN LEAVITT, P. A.

The undersigned incorporator to these Articles of Incorporation duly licensed to sell real estate under the laws of the State of Florida, adopts these articles to form a corporation under the-Professional Service Corporation Act, F.S. Chapter 621 and other laws of the State of Florida.

Article I Name

The name of this corporation shall be DAWN LEAVITT, P.A.

Article II Commencement & Duration

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Florida Department Of State. This corporation's duration shall be perpetual.

Article III Purpose

The professional service corporation is formed to engage in every phase of the sale and rental of real property as a licensed real estate agent in the State of Florida. The corporation may invest funds and own real and personal property necessary for the rendering of professional services.

Article IV Capital Stock

This corporation shall have the authority to issue 5000 shares of Common Stock, with a par value of \$1.00 per share of common stock.

Article V Preemptive Rights

Such offer shall be in writing, signed by the shareholder, sent by registered or certified mail to this Corporation at its registered office address, and open for acceptance by this Corporation for a period of fifteen days from the date of the mailing. If this Corporation fails or refuses, within such period, to make satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to dispose of such shares without any further restrictions.

On the death of any shareholder, this Corporation shall have the right to purchase any shares of the capital stock of this Corporation owned by the shareholder immediately prior to the shareholder's death, on the terms set forth above, and this provision shall be binding upon the personal representative of the shareholder.
