**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation shall be LOGAN TRANSITION CORPORATION, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing this Articles of Incorporation with the Department of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue TEN THOUSAND (10,000) shares of common stock with par value of \$1.00 per share. Each share shall entitle the holder thereof to vote at any meeting of the stockholders. There shall be no separate classes of stock of the corporation.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the issuance of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The initial principal offices of the corporation shall be located at 1200 W. Platt Street, Suite 100, Tampa, Florida 33606 and the initial registered agent of the corporation shall be Thomas K. Morrison.

ARTICLE VII - PRINCIPAL CORPORATE OFFICE

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

ARTICLE XII - AMENDMENT

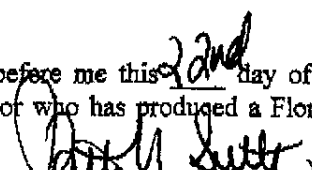

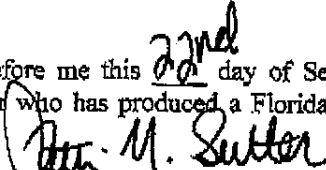
