**ARTICLES OF INCORPORATION**  
**OF**  
**RIVAS, WEIL, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

**ARTICLE I:**

The name of the corporation is: **RIVAS, WEIL, INC.**

**ARTICLE II:**

The duration of the corporation is perpetual.

The purposes for which the corporation is organized are:
