

**ARTICLES OF INCORPORATION
OF**

PRITECH PROFESSIONAL REAL ESTATE INSPECTIONS, INC.

The undersigned Incorporator to these Articles of Incorporation, a natural person, competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I. CORPORATE NAME

The name of this corporation shall be PRITECH PROFESSIONAL REAL ESTATE INSPECTIONS, INC.

ARTICLE II. INITIAL PRINCIPAL OFFICE

The street address, and the mailing address of the initial principal office of the Corporation is: 4855 Hyatt Lane, Pace, Florida 32571.

ARTICLE III. CAPITAL STOCK

The number of shares the corporation is authorized to issue is 7,500. No preemptive rights are to be granted to shareholders.

ARTICLE IV. REGISTERED OFFICE AND INITIAL REGISTERED AGENT

ARTICLE V. INCORPORATOR
