

ARTICLES OF INCORPORATION

PHOENIX INTERNATIONAL INSURANCE COMPANY DOCKSTED BY. MEP

ARTICLE I. Name

The name of the corporation shall be PHOENIX INTERNATIONAL INSURANCE COMPANY.

ARTICLE II. Principal Office
