We, the undersigned, as proper persons acting as incorporators of the corporation under the laws of the State of Florida, adopt the following articles of incorporation:

**ARTICLE I - NAME**

The name of the corporation is A.B Jones Construction, Inc.  
800 Woodside Avenue, Clearwater, Florida 33746

**ARTICLE II - DURATION**

The period of its duration is perpetual.

**ARTICLE III - PURPOSE**

The general purpose for which this corporation is organized is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, and to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**ARTICLE IV – CAPITAL STOCK**

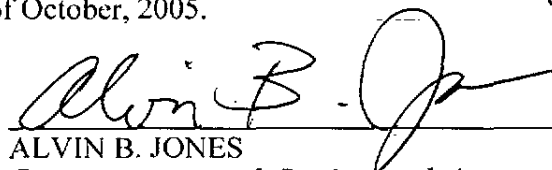

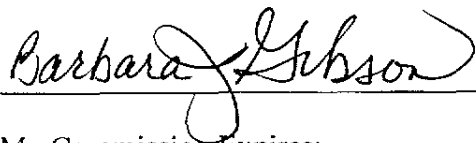
