ARTICLES OF INCORPORATION

OF

HEFFNER PERFORMANCE, INC.

The undersigned subscriber to the articles of incorporation, CHAD WILLIAMS, who is a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE 1.

Name

Term of Existence
