

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

### ARTICLE ONE

### ARTICLE TWO


The address of the principal office of the corporation is 104 Bahia Vista Drive, Niceville, Florida 32578, and the mailing address of the corporation is the same.


### ARTICLE FOUR

## ARTICLE SIX

The general purposes for which the corporation is organized are:

1. To engage in the business of manufacturing and providing decking for piers at docks, building and repairing both for the general public and small commercial waterfront locations.
2. To transact any other business for which a corporation may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the stockholders and directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
