

STATE OF FLORIDA ARTICLES OF INCORPORATION

OF

FIRST The name of this corporation is John Batchelder, Inc.

SECOND. Its registered office in the State Of Florida is to be located at 90 Highland Avenue, #1104, Tarpon Springs, Florida 34688, County of Pinellas. The registered agent in charge thereof is John Batchelder, 90 Highland Avenue, #1104, Tarpon Sprungs,, Florida 34688.

THIRD. The nature of the business and, the objects and purposes proposed to be transacted, promoted, and carried on, are to do any or all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world.
