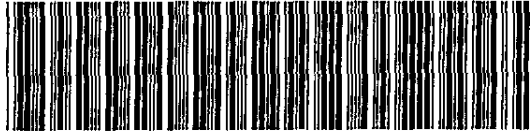


This corporation shall indemnify any officer or any former officer, to the full extent as provided for by law.


