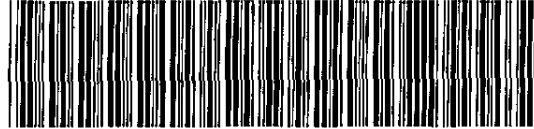

ARTICLE I – NAME

The name of this Corporation is:

The shares of stock may be issued for such consideration, having a value of not less the par value of the shares issued therefore, as is determined from time to time by the Board of Directors, to be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation.
