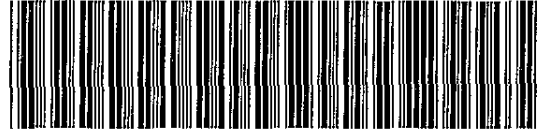

ARTICLE I

The name of the corporation is LORI LINK CONCRETE INC.. The street address of the initial registered office of this corporation is 6360 Irving Road Cocoa, FL 32927. The name of the initial registered agent of this corporation at that address is Lori Link.

ARTICLE II - DURATION

The corporation shall exist perpetually, commencing at the time of filing these articles with the state of Florida.

ARTICLE III - PURPOSES

This corporation is organized for the purposes of transacting any or all lawful business.
