

ARTICLES OF INCORPORATION  
OF

ARTICLE I. NAME

The name of this corporation is  
DANIEL SMITH CONSTRUCTION, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of

ARTICLE IV. CAPITAL STOCK

\$10.00 par value common stock, which shall be designated


