FINAL JUDGMENT OF SIMPLIFIED DISSOLUTION OF MARRIAGE

This cause came before this Court for a hearing on the parties Petition for Simplified Dissolution of Marriage. The Court, having reviewed the file and heard the testimony, makes these findings of fact and reaches these conclusions of law:

1. The Court has jurisdiction over the subject matter and the parties.
2. Both parties have been residents of the State of Florida for more than 6 months immediately before filing the Simplified Petition for Dissolution of Marriage.
3. The parties have no minor or dependent children in common, and the wife is not pregnant.
4. The marriage between the parties is irretrievably broken. Therefore, the marriage between the parties is dissolved, and the parties are restored to the status of being single.
5. Marital Settlement Agreement: The parties have voluntarily entered into a Mediated Marital Settlement Agreement, and each has filed the required Financial Affidavit. Therefore, the Mediated Marital Settlement Agreement is filed as exhibit A in this case and is ratified and made a part of this final judgment. The parties are ordered to obey all of its provisions.

6. The Court reserves jurisdiction to enforce the marital settlement agreement.
