## ARTICLES OF INCORPORATION OF SUNSTATE FINISHING, INC.



#### ARTICLE I - NAME

The name of this corporation is SUNSTATE FINISHING, INC..

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually. This corporation shall commence to do business on November 1, 2005.

#### ARTICLE III - PURPOSE
