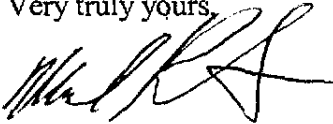

The undersigned incorporator, James T. Long, Jr., hereby forms Michfa, Inc., a corporation under Chapter 607 of the laws of the State of Florida.
