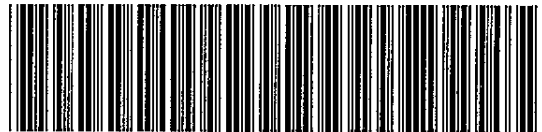



**ARTICLES OF INCORPORATION
OF
SMITH'S TRENCHING SERVICE, INC.**

ARTICLE I. CORPORATE NAME.

The name of this Corporation is Smith's Trenching Service, Inc. .

ARTICLE II. PRINCIPAL OFFICE.

The principal place of business and street address of this Corporation is 5759 NW CR 340, Bell, Florida 32619, and its mailing address is 5759 NW CR 340, Bell, Florida 32619.

ARTICLE III. CAPITOL STOCK.

The number of shares of stock that this Corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share. ARTICLE IV. INITIAL REGISTERED AGENT AND OFFICE.

The street address of the Corporation's initial registered office is 5759 NW CR 340, Bell, Florida 32619, and the mailing address is 5759 NW CR 340, Bell, Florida 32619, and the name of the Corporation's initial registered agent at that office is Tiffany M. Smith.

The Board of Directors from time to time may move the Registered Office to any other address in the State of Florida.

ARTICLE V. INCORPORATORS.

ARTICLE VIII. BOARD OF DIRECTORS.

ARTICLE IX. INITIAL DIRECTORS AND OFFICERS.



