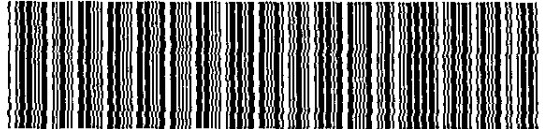

ARTICLE I - NAME

The name of this Corporation is Dockmaster of Lake County, Inc. and the address is 1923 Hilltop Drive, Mount Dora, Florida 32757.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS

This Corporation may engage or transact in any or all activities or businesses permitted in the laws of the United States of America and the State of Florida.
