George Morales is *deleted* as Registered Agent of the Corporation.

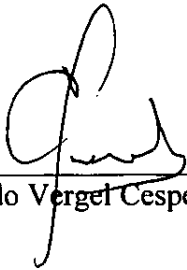
Rolando Vergel Cespedes shall be the new Registered Agent of the corporation at 5001 SW 74th Court, Suite 103, Miami, Florida 33155.

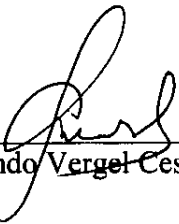
