The Undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: **Richard Alan Construction, Inc.**

ARTICLE II - ADDRESS OF THE PRINCIPAL OFFICE

Located in Seminole County, the principal place of business and street address of this corporation shall be: **204 West 17th Street - Sanford, Florida 32771**


