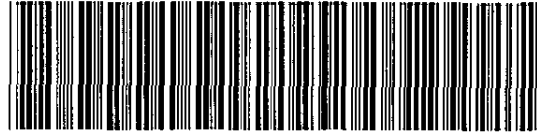

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I  
NAME AND PRINCIPAL OFFICE**

The name of the corporation shall be **Blue Web Technologies, Inc.** and its principal office is located at 2412 Gulf Breeze Avenue, Pensacola, Florida 32507.

**ARTICLE II
