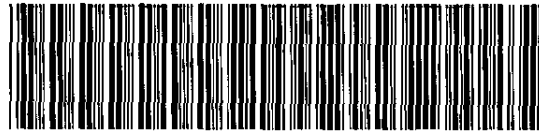

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE 1 NAME : The name of the corporation shall be H.E. Canterbury Associates, Inc.

ARTICLE 2 DURATION : The corporation shall have perpetual existence.

ARTICLE 3 PURPOSE : The purpose of the corporation is to engage in any activities of business permitted under the laws of the United States and Florida.

ARTICLE 4 CAPITAL STOCK : The corporation is authorized to issue 1000 shares of common stock, at a par value of ONE (\$1.00) DOLLAR per share.

ARTICLE 5 INITIAL REGISTERED OFFICE AND AGENT : The name and address of the initial registered agent and office of the corporation is Hermas E. Canterbury whose address is, 6007 Fall River Dr. New Port Richey, FL 34655. This is also the mailing address.

ARTICLE 6 INITIAL BOARD OF DIRECTORS : The corporation shall have one (1) director initially. The number of directors may be increased from time to time by amendment of the bylaws in the manner provided by law, but shall never be less than one (1). The name and address of the person who is to serve as the initial director is Hermas E. Canterbury whose address is 6007 Fall River Dr., New Port Richey, FL 34655.

ARTICLE 7 INCORPORATOR : The name and address of the incorporator is Hermas E. Canterbury whose address is 6007 Fall River Dr., New Port Richey, FL 34655.

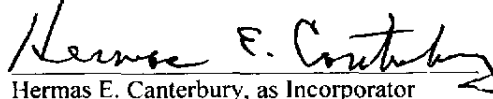
