The duration of this corporation is perpetual.

## **ARTICLE III (Purpose)**

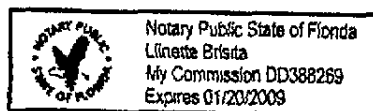

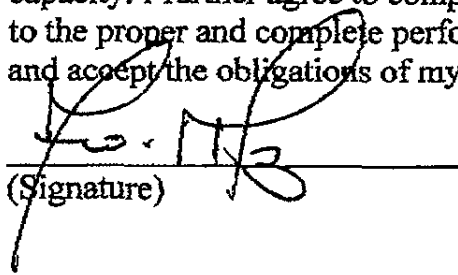

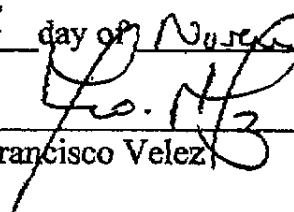
