ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of this corporation is Rulison Investments, Inc. and its principal place of business shall be located at 6177 CR 625, Bushnell, Florida 33513.

ARTICLE II DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
