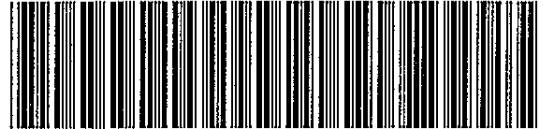

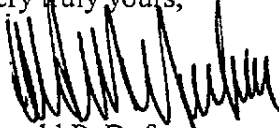

ARTICLE I- NAME AND ADDRESS

The name of this corporation is CAL REAL ESTATE VENTURES, INC. with its principal address at 1001 Amherst Avenue, Davie, FL 33325.

ARTICLE II- DURATION
