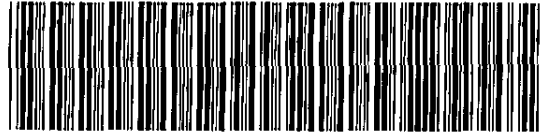

The undersigned, desiring to form a corporation under the laws of the State of Florida, hereby certify as follows:

FIRST: The name of the corporation is:

ACCESSIBLE INTELLIGENCE, INC.

SECOND: The corporate existence of the corporation shall commence upon the filing of these articles by the Department of State and the duration of the corporation is perpetual.

THIRD: The purpose for which this corporation has been formed is to engage in any or all lawful business for which a corporation may be incorporated under Chapter 607, Florida Statutes.

FOURTH: There shall be a Board of Directors of the corporation initially consisting of one member, and all corporate powers shall be exercised by or under the authority of the Board of Directors, and the business and affairs of the corporation shall be controlled by the Board of Directors. The number of members of the Board of Directors may be changed from time to time, as provided in the by-laws.

FIFTH: The aggregate number of shares which the corporation shall have authority to issue is One Million (1,000,000) shares of common stock having no par value.

SIXTH: The address of the corporation's principal office is 1737 Lake Terrace Drive, Eustis, Florida 32726 and the mailing address of the corporation shall be the same.

SEVENTH: The name and address of the corporation's sole incorporator and registered agent is Daniel F. DiVenanzo, 1737 Lake Terrace Drive, Eustis, Florida 32726.


