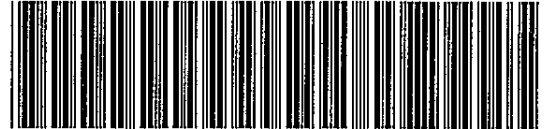

The undersigned Incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME & PLACE

The name of the corporation shall be **STEPHEN R. PARISH & ASSOCIATES, INC.** The address of the principal office of this corporation shall be 110 W. Reynolds Street, Suite 101, Plant City, Florida 33563 and the mailing address shall be the same.

ARTICLE II - EFFECTIVE DATE
