The undersigned, for purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

NAME

The name of the corporation is SAN MARCO HOTEL, INC.

DURATION

The duration of the corporation shall be perpetual.

CORPORATION PURPOSE

The general purpose for which the corporation is organized is to own and operate a hotel and any lawful business for which corporations may be incorporated under Florida General Corporation Act, and to do all the things as are necessary or desirable in order to accomplish the foregoing.

SHARES (STOCK)

- A. The aggregate number of shares which the corporation is authorized to issue is
