OF

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME**

**ARTICLE II. NATURE OF BUSINESS**

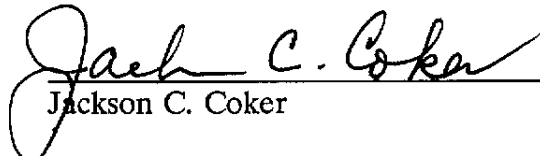

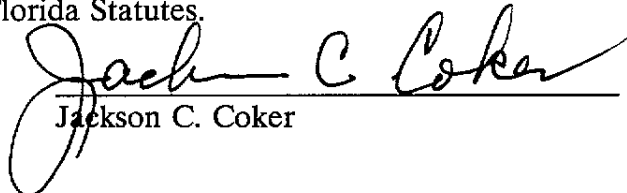
