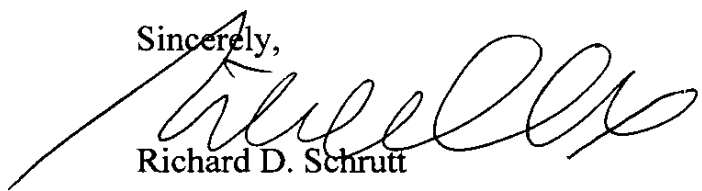
Please be advised that the above-mentioned corporation annual reports were never received for timely submission.
