The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

### ARTICLE ONE NAME & ADDRESS

## ARTICLE TWO CORPORATE DURATION

The duration of the corporation is perpetual.

### ARTICLE THREE PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

- 7. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
