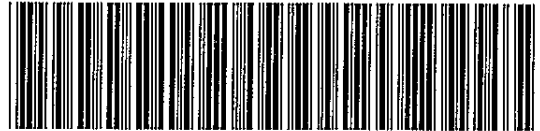

**AMENDMENT**


