

ARTICLES OF INCORPORATION OF RAFS OF DOTHAN, INC.

TALLAHASSEE, FLORIDA

The undersigned incorporator, for the purpose of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation under Chapter 607 of the Florida Statutes.

<u>Article l</u> NAME

The name of the Corporation is "RAFS of Dothan, Inc." (hereinafter the "Corporation".)

<u>Article II</u> DURATION

The period of duration of the Corporation is perpetual.

Article III NATURE OF BUSINESS

The purposes for which the Corporation is organized, which shall continue to be the purposes of the Corporation until and if the same shall be amended pursuant to the provisions of the Florida General Corporation Act, and which shall include the authority of the Corporation to transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.

Article IV DATE OF EXISTENCE

The date when the corporate existence of the Corporation shall begin is at the time of subscription and acknowledgment of these Articles of Incorporation, that is November 10, 2005.

Article V CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is one thousand (1,000) shares of Common Stock, each share having a par value of one dollar (\$1.00), such common stock being all of one class and bearing one vote per share which vote shall be noncumulative.
