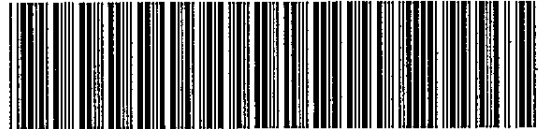

PROPOSED CHARTER OF

FRANKLIN WILLIAMS REMODELING, INC.

I, the undersigned person, hereby present myself for the purpose of forming a corporation under the laws of the State of Florida and do hereby adopt the following as Articles of Incorporation, and make this application for charter in accordance with same.

ARTICLES OF INCORPORATION

ARTICLE 1

The name of the corporation shall be FRANKLIN WILLIAMS REMODELING, INC.

ARTICLE 11

The corporation may engage in any activity of business permitted under the laws of the United States and of this State.

To engage in every aspect and phase of business of painting, framing, and drywall and remodeling, including but not limited to buy, sell, lease, sub-lease, rent mortgage, exchange real and personal property.

To represent buyers, sellers, owners, and traders in all types of painting, framing, drywall and remodeling activities and transactions.

To purchase, or otherwise acquire, to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property and services of class, kind, and description except it is not to conduct a banking, safe deposit, trust surety, express, railroad, canal, telephone, telegraph or cementer company, a savings and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

To conduct business in, have one or more offices in, and buy, hold, mortgage, sell convey, lease, or otherwise dispose of real and personal property, including franchises, patents, copy rights, trademarks and licenses, in the State of Florida.

To contract debts, borrow money issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness and execute such mortgages, transfers of corporate

property, of other instruments to secure the payment of corporate indebtedness as required.

To purchase corporate assets of any other corporation and engage in the same or other character of business.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge, or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida, and while owner of such stock to exercise all the rights to vote such stock.

#### ARTICLE III

The maximum number of shares that the corporation is authorized to have outstanding at any time shall be one hundred {100} shares of common stock with a par value of One Dollar (\$1.00) per share.

#### ARTICLE IV

This corporation shall exist perpetually unless sooner dissolved according to law.

#### ARTICLE V

The amount of capital with which the corporation shall begin business shall be Five Hundred (\$500.00) dollars.

#### ARTICLE VI

The principal office of the corporation shall be located at

#### ARTICLE VII

The number of directors of the corporation shall be one (1) or more.

#### ARTICLE VIII

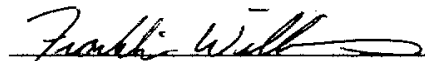
