**ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: Baldwin Park Family Physicians, PA.

**ARTICLE II**

The street address of the principal office of the Corporation is: 14955 Hawksmoor Run Circle, Orlando, FL 32828.

**ARTICLE III**

The specific purpose for which the Corporation is organized is: rendering professional medical services to the public through officers, employees and agents who are duly licensed under the laws of the State of Florida to provide such services. The Corporation may engage in any legal activity which furthers its purpose.


