**ARTICLES OF INCORPORATION
OF
CHARLES THOMPSON GENERAL REPAIR, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation within the State of Florida.

ARTICLE I

The name of the Corporation is: Charles Thompson General Repair, Inc., and the purpose for which the corporation is organized to conduct any and all lawful services in the State of Florida.

ARTICLE II

The street address of the principal office of the Corporation is: 6717 East Bay Boulevard, Navarre, Florida 32566

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 500, par value \$1.00 per share, with 500 shares to Charles Thompson.
