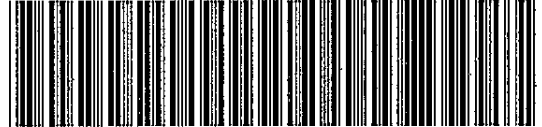

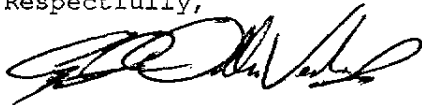

The name of the corporation is **PREMIER LAWN CARE SYSTEMS, INC.**
