**ARTICLES OF INCORPORATION (PROFIT)
OF

Ricardo Biondolillo, being of the age of eighteen (18) years old or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida.

1. The name of the Corporation shall be: **AMR Construction Group, Inc.**
2. The number of shares the corporation is authorized to issue shall be **500 shares** all of one class designated as common stock, at **\$1.00** per value.
3. The street address and county of the initial principal office of the corporation is: **9765 S. Brooke Dr. # 3006 Jacksonville, Fl. 32256 Jacksonville County** and the name of the initial register agent at this address is: **Ricardo Biondolillo.**
4. The number of the directors constituting the initial Board of Director shall be **one director** and the name and address of the person whom is to serve as director until the first meeting of shareholders or until their successors are elected and qualified is:
